**Minutes:** Laura Jeney moved to approve with no corrections the July 14, 2009 minutes. Ron Saeger seconded. The motion passed 7-0

**Public Hearing:**

SUR 09-03 – Kitzman/Sentinel Aggregate Recycling SUR

Tony Petersen presented the staff report dated August 6, 2009 and staff recommendation for approval with 17 conditions.

Discussion ensued. Laura Jeney suggested an additional condition be added that would require a tire-cleaning plan before permitting – the Planning Commission agreed

Scott Belonger asked if imports of less than 500 cy would be accounted for since no permit is required for imports less than 500 cy. Petersen stated that with the conditions as proposed, imports under 500 cy could be unaccounted for unless the operators informed staff of all such imports.

Laura Jeney asked about a previous staff recommendation that would establish periodic site inspections to verify rock import accounting. Petersen stated that staff would verify compliance of the 100,00 cy maximum rock storage capacity before any new grading permits would be issued but that account verification was unnecessary due to the relatively small amounts that would likely go unaccounted.

The chair asked for public comment. No public was present and no public comment was offered.

Ron Saeger moved to approve SUR 09-03 with 17 staff conditions and an added condition requiring a tire-cleaning plan. Scott Belonger seconded. The motion passed 7-0.

**Meeting Adjourned:** Ron Saeger moved to adjourn. Scott Belonger seconded. The motion passed 7-0. The meeting was adjourned at 7:55 pm

A more detailed plan will be discussed during the November Public Hearing.


**Other:**

Planning Commission comments: What type of lighting will be used.


Applicant will wait until further notice regarding zoning, before coming back to the board.
